Terms: *Payment will be made with in Ten (10) business days upon delivery and accepted grade of Oil Seed, by the delivery point set forth by PCOM and this contract.*

Seller will (with in two weeks of planting) verify to the buyer that the oilseed crop has been planted, Buyer will have access at all times to monitor the condition of the crop.

- 1) Lower grades will discounted at the prevailing market discount on settlement date.
- 2) Seller agrees to deliver the oilseed to the buyer's specified delivery point on or prior to the settlement date.
- 3) Control of the grain, risk of loss, and the title to the oilseed shall remain with the Seller until the oilseed is delivered and accepted by the receiving elevator. It is made on verification of elevator receiving and grading of oilseed. The buyer will pay seller within ten business days by mail. If the grain is in store at the settlement of the contract buyer's elevator it will be insured as required by the United State Department of Agriculture.
- 4) If the buyer is notified that the oilseed sold herein has a lien against it, proceeds will be payable jointly to the seller and the lien holder.
- 5) It is agreed by the Seller and the Buyer that this contract shall be binding upon heirs, successors, administrators, and executors of the respective parties.
